

SUMMARY OF LIABILITIES

- (1) The above Japanese declared in his 'J' Form dated August 17th 1942:

"Declarant owes \$100.00 to the General Hospital, Vancouver, B. C., for an operation which he had three years ago."

He also stated:

"Unable to pay off this debt."

This claim has never been confirmed by the Vancouver General Hospital, however, Mr. IZUMI has no credit with the Custodian and according to his Declaration, is unable to pay this claim personally. February 25th 1945, General Hospital ledged their claim in the amount of \$137.20, with the Custodian.
