Dear Sir:

With reference to the claim lodged by you through our representative at Hastings Park for \$59.50 against the Cameron Lake Logging Co. Ltd.

We took this matter up with Messrs. P. S. Ross & Sons, Chartered Accountants, who are handling the affairs of this company and they replied to our query as follows:-

"The books of the Company show the sum of \$53.40 owing to M. Takahashi and Son, and we have on file a proof of debt filed by one Hisao Takahashi as a partner of M. Takahashi and Son under date of 23rd March, 1942, showing a balance owing in the amount of \$53.40. We, therefore, are unable to allow the January and February charges in the amount of \$6.10.

We have made a distribution to the ordinary creditors of the Cameron Lake Logging Company Ltd. in the amount of 50% of their claim, and we enclose a cheque in the sum of \$26.70 together with our circular letter to the creditors dated 29th May, 1942. We withheld mailing this as we understand that the Takahashis had been evacuated from Deep Bay at that date."

We have placed the amount of \$26.70 to your credit in this office.

Attached herewith is a copy of the Circular letter which was sent out to creditors by Messrs. P.S. Ross & Sons on the 29th May.
