PERSONAL PROPERTY SUMMARY

Re: Shoso TOMIHIRO #06185

In his declaration to the Custodian, July 29, 1942, this man, who was evacuated on March 15, 1942, declared that he owned no property in the protected area.

Chattels: Under Custodian Release, of April 1, 1943, there were shipped to this man on May 6, 1943, a bicycle and stand, one carton of records and books, box of kitchenwares, primus heater, oil lamps and picture frames. File 4012, of Mrs. Shoso TOMIHIRO, reveals that the bulk of the chattels of this couple are dealt with in her name, having been declared by her.

Accounts Refund of 1% Wage Deductions (January to June, 1941) received  
Receivable: from Provincial Government of British Columbia, in the amount of \$6.65, received in this office, and remitted to Shoso TOMIHIRO, on March 22, 1943.

Securities: 25 Royston Saving Association Certificates were sent to this office on September 25, 1945, by this man, and are on this file. Proportionate share of assets of Royston Savings Ass'n, in the amount of \$87.53, was credited to this account.

This file reveals no evidence of any other property of any kind whatever.

Your twenty-five Royston Savings Association share certificates have been received, and we are remitting to you herewith the sum of \$87.53; this being your share of the final distribution of assets of that association.

Your file shows that the chattels, which you had left in the attic of your home at Cumberland, B. C., were shipped to you in May, 1943, and that the refund of one per cent wage deductions, in the amount of \$6.65, which had been received on your behalf from the Provincial Government, was remitted to you in March, 1943.
