This was evidently wages owing to KURITA. The account of KURITA has been credited with the sum of \$37.50, representing payment of arrears of wages owing to him by the Carmia Daily News. It would seem that KURITA had underestimated the amount owing to him. This is his only credit with the Custodian.
