This man signed a declaration to the Custodian on July 30, 1942.

In his declaration this man reported twelve \$5.00 War Saving Certificates and one \$10.00 War Saving Certificates in his wife's possession. He also reported a life insurance policy with the Monarch Life Assurance Co. for \$1,000.00 in his own possession. These items did not come under the control of this office.

The account of this man was credited with the amount of \$5.80 received from the Provincial Government as refund of 1% wage deduction for 1941. This amount was remitted to him on April 10, 1943.

This file reveals no other property of any kind. The chattels of this man's family are dealt with on the file of his wife, File No. 525.
