This will acknowledge receipt of your letter on the 7th instant of two undated letters from you in rely to ours of the 23rd ultimo.

One of them was a typewritten letter and requested that we forward to you a radio and a casera. As we had just sent you an account of the sale of a radio, and as we did not have a record of any other radio of yours here, we shall be obliged if you will let us know if you had more than one that was sold. Before the funds derived from the sale of this radio are released, so require to have the R.C.M.P. receipt shich you hold, forwarded to this office, and this we ask you to do in your next letter to the Custodian.

Regarding the camera we wish to say that if you will loose forward to this office the R.C.M.P. receipt held by you we shall attend to the forwarding of the camera as you request.

Your other letter was in connection with the prices btsined for your chattels, and in realy we wish to advise that the usual procedure was followed in making the sales. The main articles were advertised in the daily papers here and when no acceptable bid was received, sale was made to Mr. Dorigan at the best price obtainable. The other chattels were sold by auction to the highest bidder. No other way of making these sales could be fair to you.
