GENERAL SUMMARY

Re: ISHII, Misayo (Mrs. Kenji) - Reg. No. 05196.

Mrs. ISHII signed a declaration to the Custodian on August 5, 1942 and was evacuated on September 9, 1942.

She declared that she owned no property of any kind.

She stated, however, that she owed three months rent, \$24.00, to Loewen & Harvey, 751 Dunsmuir Street, and that she would settle this debt before being evacuated. In the absence of any claim from that firm, we presume that she paid the claim.

A claim was filed sometime in 1942 against Mrs. ISHII, by J. W. Kelly Piano Co. Ltd., in the amount of \$57.75. Her husband had declared \$80.00 outstanding on a piano in his first declaration of March 1942 but did not mention it in his second declaration of August 1942. We are in correspondence with J. W. Kelly Piano Co. regarding this claim. J. W. Kelly advise, 23/12/46, that claim paid in full in June 1942.

This file reveals no property other than that mentioned above, namely the piano.
