GENERAL SUMMARY

Re: KANASHIRO, Kentoku - Reg. No. 15562

The above who was 16 at the time of the evacuation, signed a J. card on August 18, 1942 and was evacuated on September 30, 1942.

He declared no property or any liabilities.

A claim was filed against him by Dr. J. A. Smith on November 17th, 1943 in the amount of \$150.00. This was referred to him on November 20, 1943 and on January 22, 1944 it was referred to his father, Taro, File 698. In our letter of January 1944 we also mention a claim filed against the father by Komeya Co. Kentoku replied on behalf of his father, on February 10, 1944 that "we are not able to make payment at present." Both creditors were advised on February 22, 1944 and given the address of Taro KANASHIRO.

This summary is certified to be in accordance with the information on file.
