Thank you very much indeed for your letter dated November 23rd.

Our letter to you of November 11th and our previous letter to you of October 13th were sent to you as a result of a cheque we obtained from the Provincial Government of B. C. for \$4.50, representing refund of 1% wage deduction for the period January 1st, 1941 to June 30th, 1941, payable to a Mr. Harry Kobayashi.

Your letter clearly indicates that you were not evacuated and have no property in the protected area.

We are today instructing our Accounting Department to issue a cheque to you in the sum of \$4.50 and this cheque will be sent to you shortly.

We would deem it a favour if you could kindly provide us with the full names and police registration numbers of all members of your family who, as in your case, have been residing outside the protected area. This information is desired by this office so that our records may be complete, and we trust that we may be hearing from you shortly in this connection.
