On the 7th August, 1946, we remitted you the balance of your funds in Custodian hands and closed your account.

The recovery of a debt owed to Kumai HAGANO (File 12217) now enables us to make a pro rata payment against debts carried in his file, in which you are interested to the extent of \$36.50, and we are therefore enclosing our cheque in your favour for \$23.76, made up as follows:

Dear Sir:

This is to inform you that a balance of \$98.41 is standing in your account with this office. These funds were derived from the following sources:

Your account was credited with the sum of \$3.03 as refund of one per cent wage deduction for 1941.

Your account was credited with the sum of \$65.38 as proportionate share of the assets of the Royston Savings Association, on the basis of 25 shares. From this sum was deducted \$22.15 being half the amount of the loan and interest due the Association from K. NAGANO, for which loan you were an endorser. If you will send us the 25 Share Certificates which you hold, we will be able to remit to you this money.

Your wife reported that you were the owner of a house at Cumberland. This house was found to be on property owned by the Canadian Collieries Ltd., and although that company was in no way obligated to do so, they allowed a salvage value on this house of \$30.00, which sum was sent to this office and placed to your credit here.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian, and in order that you may confirm this, we enclose a stamped, addressed envelope for your convenience in replying.

This man signed no declaration to the Custodian at any time.

However, the account of this man was credited with the sum of \$3.03 as refund of 1% wage deduction for 1941.

Our file shows that this man was a member of the Royston Savings Assn. and his account was credited with the sum of \$65.38, being proportionate share of the assets of the association less payment on loan and interest of NAGANO, for which loan he was an endorser.

The wife of this man declared that he was the owner of a house at Cumberland. This house was found to be on property owned by the Canadian Collieries Ltd. and although they were in no way obligated to do so they allowed a salvage value on the house of \$30.00. This was credited to the account of Mrs. ODA but as she declared the house to be the property of her husband we are transferring the \$30.00 to his account.

This file reveals no other property of any kind.

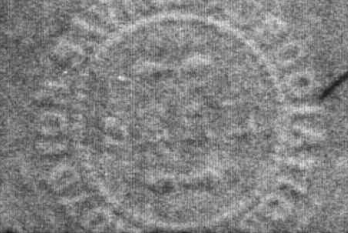

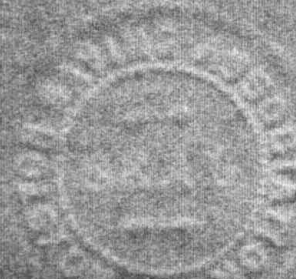
