



Re: Royston Saving Association.

We are in receipt of your letter of the 21st ultimo enclosing 25 certificates, each representing 1 share of the Royston Saving Association, and note that you desire to receive your share of the Association's assets.

In compliance with this request we are issuing a cheque in your favour for \$87.53 in full and final payment of your share of the above Association's assets in our hands. As you are a resident of a Department of Labour, Japanese Division, Interior Housing Area this cheque is being handed to them for delivery to you.

In reviewing your file we note that you owned no land or buildings in the Protected Areas of British Columbia.

You declared ownership of \$70.00 War Savings Stamps, which remained in your possession and did not come under our care.

The 1% wage deductions made by the Government during the period, January/June, 1941, which in your case totalled \$4.28, was eventually refunded and credited to your account, and remitted to you on the 27th April, 1943.

There are no claims registered against you and this brief review appears to account for all assets disclosed in your file. To complete our records please let us have your acknowledgment of this letter and remittance. We enclose a stamped addressed envelope for your convenience in doing so.
