Rossever, in July, 1942, he wrote that his personal property had been left with Richimosuke KITAMURA, File No. 10871. He gave no details of what these effects were and although KITAMURA did declare some friends' goods these were quite indistinguishable from his own. We have done nothing further, therefore, with regard to this personal property.

The account of this man was credited with the sum of \$4.91 received from the Provincial Government as refund of 1% wage deduction for 1941. This amount was remitted to him on July 2, 1943.
