This will acknowledge receipt of your letter of the 18th ultimo, advising us that the above mentioned Japanese forwarded certain War Savings Certificates for redemption, and our Cheque No. A 487670 for \$44.20 has been

From your remarks we do not understand whether the cheque was received and subsequently lost, or whether it was never received by the registered owner. We have no record at the present time of any previous correspondence on the subject. In order that the matter may be adjusted as soon as possible, we shall be pleased to have you advise us of the particulars of the case. This is necessary because a form must be completed by the owner for either non-receipt or receipt and loss of the cheque.
