GENERAL SUMMARY

Re: NOMMA, Seiji - Reg. No. 08007.

The above signed a declaration to the Custodian on August 22 (?), 1942 and was evacuated on August 25, 1942.

He declared the following, none of which were brought under the control of the Custodian.

1 - One \$10.00 and two \$5.00 War Savings Certificates in the owner's possession;

2 - A joint account with his wife Shizue, with the Bank of Montreal, Main and Hastings, Vancouver, showing a balance of \$1.50;

3 - A life insurance policy in the amount of \$2,000.00 with the Manufacturer's Life Insurance Co., the policy being in his own possession.

He also declared that he owed the Manufacturer's Life Insurance Co. the sum of \$76.70 being premium for 1942 plus interest on unpaid premiums. The file does not disclose whether this was paid.

This file reveals no assets other than those mentioned above nor does it disclose any liabilities other than the Life Insurance premium.

This summary is certified to be in accordance with the information on file.
