

However carbon copy of letter August 10, 1946 by Custodian to Mrs. Yori YAMASHITA, Mother of Sadako YAMASHITA refers to a Provincial Board of Health bill for \$729.00 and Department of Labour Jap. Div. bill for \$204.00 which bills relate to Sadako YAMASHITA. These Claims, however, have been dealt with and disposed of in file #6767 Yori YAMASHITA.

No other indebtedness is indicated on the file.
