MEMORANDUM

Re: I. FUJIOKA, #07758

A waster radio and 4 Boxes of Ceremonial dolls were found at 406 Alexander Street, tagged I. Fujioka. They were removed to the warehouse and subsequently sold at auction for the net sum of \$6.79.

Being unable to identify I. Fujioka, we wrote to Mrs. Kaku KAWADA, former operator of 406 Alexander Street, a rooming house, asking her to furnish us with the full name of I. Fujioka. We have now received a letter from Mrs. Iaye FUJIOKA, Registration 07758, File 11932, as follows:

"I have been informed by Mrs. Kawada, that you are in possession of my chattels which were left in her home at 406 Alexander Street, Vancouver.

"It would be appreciated if you will credit same to my name."
