We have for acknowledgment your letter of the 23rd instant in which you ask for information concerning the above.

Our files indicate that both Shunji and his wife, Hara returned to Japan under the repatriation scheme, both sailing on the General Heige on 2nd August 1946. At the time they left Canada they turned in certain sums of money which were handed to the Treasury Department to be forwarded to them in the usual manner, and we have no record of any debts either due to the Treasury or to any other parties.
