Mrs. Toshie NISHIKAWA, now deceased, declared 7 boxes of kitchenware left at 833 West 7th, being the premises owned by Mr. Tonijiro NISHIKAWA. Her declaration is duplicated in greater detail by her husband on File 1774. } in below

Mr. Seitaro NISHIKAWA declared the following things left here (presumably in the attic as per letter of May 15th, 1944):

7 Boxes containing household effects, goods and tools  
2 Pictures with frames.

3 of the boxes were shipped him on May 25th, 1944 and 2 crates of books on June 14th, 1944, the balance of 4 boxes, 1 shrine and 1 tool box, being left here for a fuller description of exactly what was wanted by him.

All the contents of 833 West 7th were finally moved to storage on File 10107 and sold at auction as Tonijiro's on July 12th and July 25th, 1944, except the items as per list No. 564 of July 12th marked "T. and S. NISHIKAWA". Can these be separated? \*

When you have looked into this, please return the files to me and I will then write to Tonijiro and point out that the auction proceeds included some of the possessions of Toshio. Most of these proceeds have already been sent to him, but as the two are probably brothers, no very great harm will have been done. }
