The above Japanese made his declaration to the Custodian on March 2nd, 1943 and was evacuated on March 10th, 1942.

He declared that a few effects belonging to him were left at 835 Cordova Street, Vancouver, B. C.. Inquiries by our fieldmen at this address disclosed that the tenants of this house had been there since the Japanese left and that nothing but rubbish and junk was found when they moved in. This was thrown out by them.
