It was sold at Vancouver Radio auction #1, December 20th, 1943 and realized the net sum of \$17.45 as per sales sheets on file. This amount was placed to the credit of Ghogoro YOSHII.

ACCOUNTS RECEIVABLE: Mr. TOSHII'S J. P. form states that he had a bank account but further particulars were not given. This did not come under the control of the Custodian.

No property interests other than those mentioned above are found on this file.
