GENERAL SUMMARY

This woman signed a declaration to the Custodian on August 27, 1942, in which she stated that she owned no property of any kind whatsoever in the protected area.

The only property of any kind revealed by this file is a camera, which was not surrendered by Mrs. CHIBA, but was left in the care of Mrs. H. Barclay, 2940 East 1st Avenue, Vancouver. On February 23, 1946, Mrs. Barclay informed this office that she had sent the camera to Mrs. CHIBA at New Denver Sanitorium.

Two claims were filed against Mrs. Chiba, as follows:

1. Retail Credit Grantors' Bureau Ltd. for Drs. Cox & Johnson, Dentists - \$42.00
2. Provincial Board of Health, Tuberculosis Division - Hospitalization - \$1,206.00

No funds have, at any time, been to the credit of Mrs. Shitsuka CHIBA with this office. All funds paid into the account of Kinsaburo CHIBA, husband of this woman, have been distributed to his creditors. Therefore no further action will be taken by this office in regard to these claims.

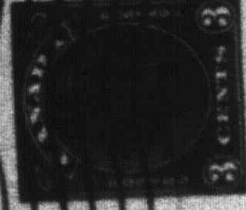

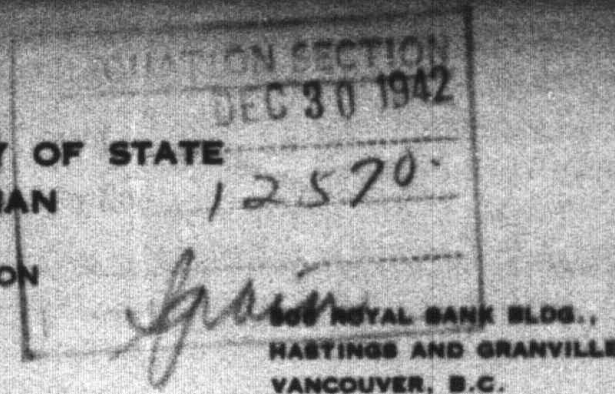
