In his declaration to the Custodian on January 10, 1944, this man declared no property of any kind in the protected area.

This man was evacuated on March 7, 1942, and on August 28, 1942, we received a release signed by him at New Denver in connection with a small box of tools which were stored at Hastings Park Baggage Room in the name of Mrs. M. Kodama, who presumably was his wife, Mitoka Kodama.

A camera, which had been surrendered by Mrs. E. W. Gaunt, 8258 Oak Street, Vancouver, on behalf of S. Kodama, Selkirk Street, Vancouver, was recorded in this file, but the receipt for this camera was sent to this office by Miss Sachiko Kodama, step-daughter of this man, File 10316, and the camera was mailed to her on November 1, 1945.
