Satoru KOYANAGI was evacuated on March 11th, 1942, and made his declaration to the Custodian on December 13th 1943.

CHATELAIN

None were declared but on August 22nd, 1942, he asked the Custodian to release some tools that were left at 352 1/2 Heatley Avenue, Vancouver, and it would appear that these were taken away by his wife Sueko KOYANAGI on her evacuation.

BANK ACCOUNT:

The declarant stated he had an account with the Bank of Montreal, Vancouver, (a/c #1483), the balance of which was 278.80. On December 14th, 1943, he requested the Bank of Montreal to transfer this to the Custodian for purposes of paying his Life Insurance premiums. Bank of Montreal, Main and Hastings Street Branch, remitted \$278.80 to the Custodian on January 26th, 1944 and a balance of \$11.55 now remains with them on deposit. KOYANAGI has been requested to forward his pass book so that this balance can be transferred to the Custodian.


LIFE INSURANCE:

The declarant states he had a Life Policy with the Monarch Life Company #P113403 (20 year Endowment). At his request \$90.80 was paid on this policy on account of 1944 premium and \$100.85 on account of 1945 premium.

REFUND:

The Custodian received on his behalf a refund of \$2.97 from B.C. Electric Railway Company, representing security deposit for light.


