LEDGELINE, ALTA, Dear Maden: The Department of Labour, Japanese Divinion, have handed to us for our attention, a copy of your letter to them of June 5th, 1946. We have before us a copy of the rental agreement which you signed with the Walburn Noon Ltd. and have perused same in conjunction with a copy of their state out from which it would appear that you made regular monthly payments right up to the time of your evacuation from Vancourer until your payments totalies (1)2,50. This left a belance unpaid of \$137,50, and to Walburn Noon Ltd. have been approached by us and state that they are not disposed to cancel the belance of payment under the contract. We are of the opinion however, that they might be disposed to compromise if you offered to pay them a portion of the balance. If you will make some proposal to us, we will be pleased to submit it on your behalf. With reference to the pressing machine, boiler and associat burner, this oculosent was taken over by the Custodian and sold at auction for the net sum of \$55.25, and this sum credited to your account.
