

WAR SAVINGS CERTIFICATES:

Declarant stated that he had about \$150.00 in War Savings Certificates, but cashed them about July 1st, 1942.

The file reveals that the Registrar advised the Custodian on October 28th, 1942, that the declarant had sent \$50.00 face value in War Saving Certificates for redemption and that a cheque for \$40.08 had been forwarded to him at Port Moody, but that it was returned undelivered by the postal authorities.


\$45.00 in War Saving Certificates were forwarded to the Custodian for redemption on behalf of the declarant by the Department of National Defence. They were redeemed by the Registrar and the proceeds - \$36.99, together with Wage Tax refund of \$5.27 remitted to Haruo SHIMODA on May 17/44.

WAGE TAX REFUND:

Provincial Collector refund \$5.27 representing 1% Wage Deductions for first six months of 1941. This was credited to Haruo SHIMODA.
