The sister of Masami SUGIE signed a yellow "No property" card for him on Sept. 1/42 stating he owned no property of any kind whatsoever in the protected area.

He has been credited with the sum of \$2.06 being a refund of 1½ wage deductions. However this has been credited to him incorrectly as the name given by the Provincial Collector was Masayoshi SUGIE, who lived at the same address as Masami SUGIE. Masami SUGIE was only 16 years old at the time of his registration and Masayoshi SUGIE was 20. We are therefore sending this money to Masayoshi SUGIE and debiting the account of Masami SUGIE. This will leave no credit in the account of Masami SUGIE.

There are no claims filed against Masami SUGIE.
