

MEMORANDUM

TO: Mr. Johnston

FROM: Mr. Macpherson.

Re: Takeno Ono

There is nothing on these files to show that the above is deceased except that it is so stated in Mr. Green's memorandum of May 30th, 1945. Mrs. Ono made no declaration of real property and the land on which is situate 75 West Cordova, was purchased, in 1938, by Dorothy Marstrand, and has remained in her possession since.

Mrs. Ono had one-half interest in the equipment of a Barber Shop at this address and Mr. Campbell reported that the owners sold the equipment for \$100.00, and disposed of the proceeds.

In these circumstances it does not appear that Mrs. Ono has any estate and these three files may be closed.

The position here is that Chojiro Sumida file 2502, and his wife, file 12709, together with Mrs. Takeno Ono, file 12707 (now deceased), owned jointly a barber shop and some personal effects at 75 W. Cordova. Chojiro SUMIDA was evacuated on March 29th, 1942, and on October 14th, 1942 the remaining partners declared on file 12709 that all their property in the protected area had been disposed of. These files may now, therefore, be closed but file 12707, being an estate, is being sent to Mr. Johnston for his consideration.
