



CHATELS: - On page 2 of registration dated Sept. 4/42 FUJIWARA declared as at 568 Powell Street, Vancouver, B.C. :-

"1 bed, kitchen utensils, 1 table, 1 trunk" in Room 8.

Under date of Nov. 6/42 W. Kenneth Labron reported:-

"Mr. Fujiwara was a tenant in a rooming house at 568 Powell Street. This building has now been entirely vacated by the various Japanese tenants, and we have no record of any effects belonging to Mr. FUJIWARA."

Under date of November 14/42 the Custodian wrote to FUJIWARA at Slocan Extension, B.C. as shown by letter on file indicating that he "had sold or taken away" his chattels. To this FUJIWARA agreed by signing and returning the letter. This closed the matter of chattels of FUJIWARA.

On Page 3 of Registration dated September 4, 1942 by FUJIWARA is recorded:-

"List of moneys owing from Customers, will be brought in later".

There is no record that such list was ever received by the Custodian.


No other assets of FUJIWARA are revealed on the file.


The Claim indicates "I rented the premises and I operated a poolroom".
