

MEMORANDUM

To: Administration Dept.

re: Dr. Harold Mitsugi SHIMOKURA

On File No. 12814, Harold Mitsugi SHIMOKURA, is a letter dated February 10th, 1944 from Tashiro, S.C. from H.M. Shimokura, which reads as follows:

"Thank you very much for your past services. Regarding Miss Miura's account (now Mrs. A. Usukawa) File No. 8971, 12814. I can definitely say that it is not paid for, but with us people the times are very hard and I do not wish to make it any worse by making harsh demands now. I think I can fix things up without any trouble after the war so please drop the matter altogether for the present.

This also goes for all the other unpaid accounts. I hope you will understand."

We interpret this to mean that "All the other unpaid accounts of Dr. Shimokura on the various files are to be disregarded, and no further action taken by the Office of the Custodian to collect these accounts.
