RE: Rikichi ENOMOTO

The latter declared on his J.P. form, dated Sept. 16th, 1942, 2 small trunks containing books and documents, stored at G. H. Cottrell Ltd., 349 Railway St., Vancouver, B.C.

In Nov., 1942, we wrote to G. H. Cottrell Ltd., and asked them if they had in storage 2 trunks belonging to the above. They replied that they did have two trunks belonging to Mr. ENOMOTO. In Feb, 1945, we were advised that storage charges amounting to \$24.00 were owing by Mr. ENOMOTO on the trunks. We wrote twice to Mr. ENOMOTO but received no reply. We wrote to the B.C. Security Commission and asked them if they would have their Supervisor at New Denver interview Mr. ENOMOTO and find out what he was going to do about these storage charges and what he wished done with the trunks. We later received a letter from G. H. Cottrell Ltd. advising us that they had been requested by Mr. ENOMOTO to ship the trunks to him and asked us whether it would be in order for them to comply with this request. We wrote them on Sept. 1, 1945, and advised them to ship the trunks but told them they would have to protect themselves as far as storage and shipping charges were concerned as Mr. ENOMOTO had no account with this office.
