We are in receipt of your letter of February 28th and beg to advise that the wife, Matsuyo KAJI, has no assets registered with the Custodian.

Jiro KAJI has a balance with us of \$5.14, representing refund of Income Tax. In his declaration to us he stated that he had no assets.

J. KAJI has claims filed against him for \$48.78.

On August 29, 1942 Jiro KAJI stated that he was receiving \$13.86 a week from the Workmen's Compensation Board, however, we do not know whether these payments have stopped or not.
