This cheque, in the amount of \$141.00 was credited to the account of the above with this office.

Peers: Dear Sire: Re- KAWASAKI, Yoso (Mrs. Mohachi) Further to my report to you of the 28th of September I have been contacted by Mr. Anderson and he advised me that he has arranged to purchase the balance of the fixtures and equipment, owned by the above declarent in connection with her confectionery business at 300 Powell Street. He further advised me that the amount which he is paying for these is \$400.00, and that he has already turned over to Mrs. Kawasaki an amount of \$250.00 on account. I have instructed him that the balance of the purchase price is to be paid to me for transfer to your Office to be placed to the credit of Mrs. Kawasaki, which he has agreed to do. I would point out that my representative advised Mrs. Kawasaki that it would be necessary for the sale of these fixtures to be supervised by myself, as your Agent, and the funds disbursed through your Office, and that this action on her part has been effected without reference to myself. I do not believe, however, that this is a matter of any consequence as there are apparently no creditors' claims and the balance of \$150.00 will presumably be under your control. Yours very truly.
