



On File #5150 it is noted that the contents at 640 East Cordova Street including chattels, fixtures, Equipment and machinery were sold under Bill of Sale dated January 24th, 1944 to John Joseph King. The appraisal of Furniture by Alberta Furniture Co. as January 4th, 1944 indicated same as of little saleable value. The items declared by Gunji SANMIYA do not appear itemized in the said Bill of Sale. The proceeds of the sale have been credited to Mrs. SANMIYA, File 5150, and so reported to her.

She has also been advised of the incident that Gunji SANMIYA stated that he had certain named articles there.
