**MEMORANDUM**

December 8, 1942

The Canadian Liquid Air Co., Ltd. in their letter dated December 2nd requested information regarding any welding equipment previously owned by Shigeo YAMAKA (File No. 12978) and his brother, Shoichi YAMAKA (File No. 11852).

When Mr. Shigeo YAMAKA registered his assets with the Custodian on September 24, 1942, he declared that his business had been sold previously and that all stock had been sold to a number of different individuals, that payment had been received in full, and that he had no record of the names of the purchasers in question.
