Dear Sir: RE - Shrines of Mr. Kumakichi Miyauchi and Mr. Unokichi Takenaka. Thank you for your letter giving me the necessary information regarding shrines belonging to Rumakichi Mivauchi and Unokichi Takenaka. I am sending a rough diagram of the shrine of Mr. Miyauchi, on a separate sheet. Or Mr. Takenaka's shrine I have the following description. It is about 3 feet high, 18 inches wide and 15inches deep. There is supposed to be a stand for it. The hanging latern is or rlower design. There is a small bell inside which has the diameter or about 3 inches. The shrine is described as black outside and black and gold inside. The owner states there may be scriptures on tablets in the shrine, with their names in Japanese characters written on them.
