GENERAL SUMMARY

Hideo AOKI, Deceased.

Hideo Aoki died in Vancouver, B. C., on October 4, 1942. His only living relative of which we have knowledge is his father, Kyuichi Aoki, Registration No. 13209, File No. 5060.

The file of the deceased shows a claim made by the Provincial Mental Hospital. This was settled by Kyuichi Aoki on November 16, 1944 (see File No. 5060).

The deceased, Hideo Aoki, declared no assets or liabilities at the time of registration. On May 7, 1943, however, his account with the Custodian was credited with the sum of \$4.07, being redemption value of War Savings Certificate.

We are, today, transferring this credit balance to the account of his father, Kyuichi Aoki, File No. 5060, and closing the account of Hideo Aoki, File No. 13059.
