Dear Sire

#### Res Fire Insurance.

I wish to acknowledge your letter of February 20th in which you ask us to place \$1,500.00 on your chattels stored at Bownan's through the Office of the Equitable Life and to transfer the coverage under the existing North Yest Policy \$205297 to cover your furniture at New Denver.

With regard to transferring the coverage under this North Fest Policy to New Denver, —that can be done, but in order to do so you will have to supply the details of the risk, that is, a description of the building in which the chattels are at present contained, and, until and unless this is done the coverage under the North West Policy could not be transferred to cover at the new location.

Becondly, with regard to placing insurance at Fowmen's through the Equitable Life Office, —that can be done, but I would like to point out that we have no fund here to the credit of your account with which to pay the premium.

Instead of transferring and placing insurance as you request in your letter of February 20, say I suggest that it would be much better to have the North West Company cut the amount down under their policy \$205297 in line with the value of chattels now stored at Rosman's, and at the same time transfer the coverage to that location. Incidentally, I have requested the Office of McGregor, Johnston, & Thomas, Agents for the North West Fire Insurance Company, to hold you covered under this policy \$205297 to the extent of \$1,000.00 pending your resty to this letter.

Insofar as the Insurance Protection you need on your personal property now at New Denver, I would suggest that you contact
