PERSONAL PROPERTY SUMMARY

Re: Chiyeko KOTANI, Reg. No. 00500

This woman signed a declaration to the Custodian on October 14, 1942, nine days before her evacuation.

In this declaration the only property reported was a Crown Life Insurance policy for \$1,000.00 in the name of her son Noriyuki (minor). This did not come under the control of this office.

On April 17, 1946, the Department of Labour sent to this office a receipt for a radio and record player surrendered by Toshio KOTANI, File 12828, and asked that these items be sent to Mrs. Chiyeko KOTANI. On May 3, 1946, Toshio KOTANI notified this office that the radio and record player had been surrendered by him on behalf of Mr. Toshio KOTANI and that he himself had no interest in these. We are therefore transferring the net proceeds from the sale of these articles, in the amount of \$58.80, to the joint credit of Mr. & Mrs. Toshio KOTANI, and will remit this sum to them.
