Further to our letter dated April 28th we are happy to inform you that we have today received from the Registrar of War Savings Certificates in Ottawa cheque No. B700061 in the amount of \$8.08 covering redemption proceeds of your \$10.00 War Savings Certificate. This sum of \$8.08 has been placed to the credit of your account with us.

You will remember that Dr. Paul Kikagai's claim against you amounted to \$8.50 and that Messrs. M. Furuya Company's claim against you amounted to \$10.25 making a total of \$18.75. 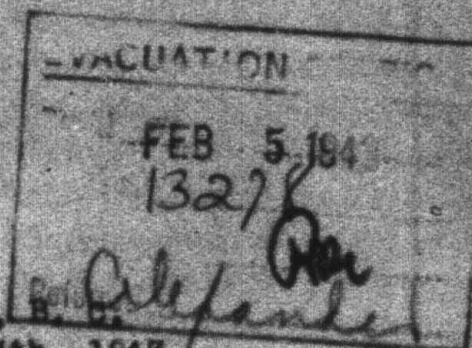

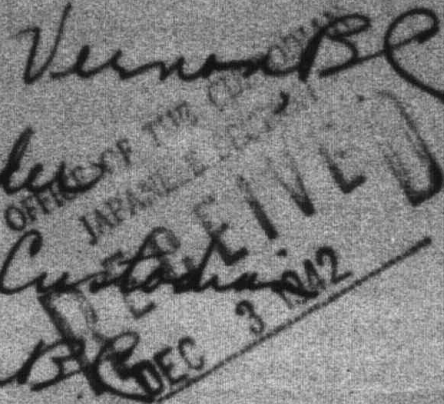
