GENERAL SUMMARY

RE: Masayoshi SUGIE, Reg. No. 01532

Masayoshi SUGIE made his declaration to the Custodian on March 3/43 and was evacuated to Westbank, B.C. (no dated given).

He declared no property of any kind remaining in the protected area.

However a credit of \$2.06 representing 1¹/₂ wage deductions has been incorrectly credited to Masami SUGIE, who lived at the same address as Masayoshi SUGIE. We are therefore remitting this money to Masayoshi and debiting the account of Masami SUGIE. This is his only credit with the Custodian.

There are no claims on file against Masayoshi SUGIE.

The above summary is certified to be in accordance with the information on file.
