



Dear Sir:

In reply to your request, we are enclosing Custodian's cheque for the sum of \$2543.87 representing all the funds standing to your credit with this office.

Your file shows that the sum of \$3036.05 was received from the Cassiar Packing Co. in January 1943 and credited to your account. This money represented the sale price of a boat, sold on your behalf by Cassiar Packing Co. less a balance which you owed the Packing Co. In order that our records may be complete, we would be pleased if you would give us the name of the vessel concerned.

From the funds credited to your account, the sum of \$450.00 was remitted to you in February 1943, and the sum of \$42.18 was transferred to Saijiro WAKITA in settlement of his claim against you, leaving a balance of \$2543.87 which is being remitted to you herewith.

The chattels which you reported to the Custodian have, according to our records, been shipped to you.

It would appear that we have accounted for all the property of every kind, which vested in the Custodian, and in order that you may confirm this and acknowledge the cheque, we enclose a stamped addressed envelope for your convenience in replying.

PERSONAL PROPERTY SUMMARY

File No. 13668

Re: Sashichi WAKANO

Reg. No. 02503.

This man who was evacuated on March 7, 1942, signed a declaration to the Custodian on December 14, 1942.

In his declaration he stated that he was the owner of a Singer Sewing Machine and 40 pounds of wool left at C.S.C. Camp, North Galiano, B. C. These articles were shipped to WAKANO on March 25, 1943.

He also declared a Singer Sewing Machine, kitchen utensils and a gas stove left at Canadian Saltery.

This file reveals nothing further in regard to the disposition of these articles.

In a letter sent to this office with his declaration, WAKANO stated that there was due him from Cassiar Packing Co. the sum of \$3,030.00. This money represented the sale price, \$3450.00, of a vessel which WAKANO had purchased through the Cassiar Packing Co. while employed by that Company and which Cassiar Packing Co. had sold on his behalf, less the sum of \$420.00 to settle a balance due Cassiar Packing Co. from WAKANO. The sum of \$3036.05 was paid to the Custodian on January 29, 1943 by Cassiar Packing Co. in settlement of WAKANO'S claim on a fishing vessel. This sum was credited to WAKANO'S account. Further details in connection with this man are given in the Vessel Summary.

This file reveals no other property either real or personal.

VESSEL SUMMARY

In his declaration to the Custodian, this man did not report ownership of a vessel. WAKANO, as a National of Japan could not be the registered or licensed owner of a Canadian vessel. However, on December 14, 1942, he wrote that the sum of \$3,030.00 was due him from the manager of Cassiar Packing Company Ltd., who had sold for \$3,450.00 a vessel in which WAKANO had invested while working for Cassiar Packing Company Ltd. The difference between the sale price and the amount of money due WAKANO was \$420.00, which the manager of Cassiar Packing Company Ltd. was to keep to settle a debt which WAKANO owed the company.

The sum of \$3,036.05 was paid to the Custodian on January 29, 1943, in settlement of WAKANO's claim on a fishing vessel.

Neither Cassiar Packing Co. Ltd. nor WAKANO have given us the name of the fishing vessel involved in this deal. However, Cassiar Packing Co. Ltd. were the registered owners of the vessel "Y.W.II", 172,340, which was impounded in December, 1941, by Naval Service, either because the vessel was in the possession of a Japanese crew or because the vessel was known to be actually owned by a person of Japanese origin.

The "Y.W. II" was requisitioned and purchased by the British Admiralty Technical Mission, and on September 22, 1942, the Japanese Fishing Vessels Disposal Committee paid to Cassiar Packing Company Ltd. the sum of \$4,326.25, in full payment of the purchase price of this vessel, \$4,374.00 less \$48.75 supervision charges of the Committee.

If the "Y.W.II" is the vessel which WAKANO had purchased through the Cassiar Packing Company, it would seem that Cassiar Packing Company have not accounted for \$836.20.

Dear Sirs:

I am an evacuee from the Coast area, and I have been living on the self-supporting basis for the duration. During the war years, I was in constant ill-health, and particularly within the last two years, including the present year 1945, I was unable to do any labour therefore had no income for the afore mentioned years. Hence I had to make a loan, my only financial support for those two ill-ridden years, from a friend, and now I am in debt with him.

In reference to your letter, file # 13663, it was stated that my fishing boat have been sold at the price of \$2586.05 (TWENTY FIVE HUNDRED EIGHTY SIX DOLLARS AND FIVE CENTS) and the amount credited to my name. I shall be much obliged if the total cash can be sent to me, and this which, will enable me to pay my debt and to meet the forecoming living costs.

Please reply me at your earliest convenience whether the credited cash can be mailed to me.

Thank you very much for the kind attention given to this letter.

Dear Sir:

An undated letter from you, received on the 15th ultimo, has been passed on to this department for reply.

Our records show that on the 29/1/1943 we received from the Cassiar Packing Co. Ltd., a cheque for \$3,036.05 for the credit of your account; that on the 10/2/1943 we sent you a cheque for \$450.00, leaving a balance of \$2,586.05 in your account. There are other entries, corrected by subsequent cross-entries but your balance today is as stated, \$2,586.05.

We note that you wish us to pay the claim of \$42.18 registered against you by Saijiro WAKITA, and this will be done.

We further note that you wish to keep your funds on deposit with the Custodian. We are pleased to see this decision as this office, in its capacity as Trustee, desires to see such capital assets conserved as much as possible to provide for future needs.

This office does not pay interest on credit balances but is always prepared to invest such balances in Government bonds, when requested to do so, collecting the interest on such bonds as due and paying it into the credit of owner's account for his use. \$2,500.00 invested in 3% bonds would yield \$75.00 per year (or \$2,000.00, \$60.00 per year) and you may be interested in so investing such funds as can be left undisturbed for a year or more. Such bonds can always be sold for cash but our purpose, to give the owner the benefit of the interest, is defeated unless the bonds are held for a reasonable length of time.
