

HAGAMANA made his declaration to the Custodian on April 9/42, was intermed May 16/42 and released Nov. 9/42. On his first declaration he stated that he had left seem clothing and a few books at his home, 1774 Possil St. Scower in a later, undated declaration, and in his letter of Peb. 7/43 he states he has no property remaining in the protected area.

His account was credited with the sum of \$1.53, which was a refund from the Frowincial Collector of 15 wage deductions for the first six months of 1941. This was remitted to him on 0ct. 22/43.

At the time he was released from Angler Internment Camp he still had \$4.00 to his credit in the camp and this sum was remited to our office to be credited to his account. This is his only credit with the Custodian.

There are no claims on file against him.
