Mrs. Ogawa now advises us that you need this money and requests that it be sent to you. We therefore enclose our cheque in your favour for \$100.00, leaving no balance in your account, which will now be closed.

In reviewing your file we note that you owned no land or buildings in the protected areas of British Columbia.

A shipment of personal effects made to you in December, 1942, accounted for all your chattels.

On the 1st August, 1945, we sent you a cheque for \$77.04 in liquidation of your interest in the Royston Saving Association.

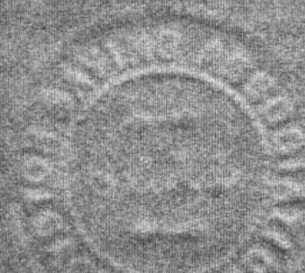
