This man died on January 16, 1942, in Vancouver. This was prior to the evacuation of persons of Japanese origin from the protected area.

The only property belonging to the estate of the deceased to come under the control of this office was the motor-vehicle described in the Specified Articles Memorandum. This vehicle was sold for the net sum of \$379.77, which was credited to the account of the estate. Four cheques totalling \$379.77 were sent to Kosaburo UNO, Reg.No.06294, File 4949, father of the deceased and Administrator of the Estate. Letters of Administration were granted to Kosaburo UNO in connection with this estate on January 30, 1942, as shown by copy filed under date of November 15, 1943, on this file.
