

1. The above named is at present in custody in the Canadian Immigration Detention Shed, Vancouver, having been arrested as an alien enemy. He is 29 years old and is employed with the Bloedel Company at Port Alberni as a millworker. He is married and his wife, Miki and one small child reside in Port Alberni.

2. This man has been interviewed by the writer in an effort to obtain information which might prove of assistance to the Custodian of Alien Enemy Property in the administration of his affairs.

3. Kuromi has very little in the way of financial assets. He has no bank account nor does he carry any life insurance. He has a \$50. Victory bond in his wife's name at home. He has no car and owns no property. He and his family reside in a house rented in Port Alberni for \$13.50 per month. The contents of this house are owned by Kuromi and are valued at \$500.

4. He acknowledges a debt to Chiyono KUROYAMA of Port Alberni of \$15. and to McDonald & Co. of Port Alberni the sum of \$80. for furniture.

5. An effort will be made at a later date to verify the information contained herein with the cooperation of the local representative of the Custodian of Enemy Alien Property.
