A large quantity of chattels from this address were shipped to him as shown on Chattel Schedule on file.

One box of goods in the name of "S. YAMAMOTO" was removed from 756 W. 7th Ave., Vancouver. This is given by YAMAMOTO as his previous address. Since the only "S.
