
Please note that the above has been repatriated to Japan. At the time of repatriation, the following transactions took place:

No Assets of Kazo TSUCHIDA are revealed on the file, except on R.C.M.P. information form dated April 30, 1943 in reference to "1 truck - 1 1/2 ton Chev. 1929".

As Kazo TSUCHIDA declared no property in the Protected Area as June 29, 1943 and as there is no other reference on the file to a truck it is assumed that he disposed of the above mentioned truck prior to evacuation.

LIABILITIES:

The following claims against Kazo TSUCHIDA are lodged on the file:-

RE:

Items Nos 1 and 2 were submitted to TSUCHIDA for payment at different times without receiving any reply. These two creditors were advised of our efforts and the result as March 24, 1943. Also in our report to the Dept. of Labour, Japanese Division, Sept. 15, 1944 in respect to No. 1.

Item #3 was filed on the daughter's file #11037 and is now removed to this file #13852. Inquiry of Prov. Board of Health ascertained that the Account was for \$894.00 with particulars of same. The patient was 16 years old when first admitted. We are advising the Board of the financial situation of Kazo TSUCHIDA according to our records.

No other claims against or indebtedness of Kazo TSUCHIDA are revealed on the file.

Replying to yours of the 15th instant regarding the above, Johel OTA'S claim against Kase TSUCHIDA is on file, only the amount is shown at \$300.00. This information was obtained from OTA'S "JP" registration form, which also states that the debt is 20 years old.

We have written to TSUCHIDA several times in connection with this debt but he has never replied. This information was conveyed to OTA by this office on the 24th of March, 1943, when we informed him that we could not do anything further to assist him and supplied him with TSUCHIDA'S address.
