ASSETS: - No Assets are declared by Yoshitaro TABUCHI when registering January 11th, 1943.

ACCOUNTS

RECEIVABLE: - Reference to an amount of \$25.00 expected from W.J. Murdock, Barrister, as per our letter 22-1-43 to Murdock is noted. Letter from Yoshitaro TABUCHI of January 30th, 1943 advises receipt of this amount.


Setsumo MIYASAKI - \$98.70 - In a letter received from Yoshitaro TABUCHI on January 26th, 1944 he claimed the above amount from Setsumo MIYASAKI. We presented the Claim but MIYASAKI denied owing by letter February 7, 1944 a copy of which letter was forwarded to TABUCHI by way of report and final action on our part.

No other Assets of Yoshitaro TABUCHI are revealed on the file.

LIABILITIES: - A Claim of M. EBISUZAKI CO. for \$6.43 against Yoshitaro TABUCHI is revealed on the file. This was submitted to TABUCHI and from his answer we assumed that he admitted owing, but did not forward any amount in respect to payment of the account. The Claimant was notified with Yoshitaro TABUCHI's address and no further action was taken by the Custodian.

No other indebtedness of Yoshitaro TABUCHI is revealed on the file.

The above Summary is certified to be in accordance with the information on file, September 19th, 1947.
