In reply to your favor of May 11th addressed to me at Lemon Creek, Slocan, B.C., enquiring me of the account with the above firm amounting to \$3.24, I beg to state that there must be a mistake on the firms part or at your Office, because of the fact that I have had no contract whatsoever with the above firm.

I may say that while I was in the coast area, I was working mostly at Galiano Island, and occasionally when I visited Vancouver District I stayed at Mrs. N. Hamagami, 723 Cordova Street East, therefore, I had no necessity for light, gas nor any electric appliances.

While I do not know actually what had happened at the firms office, my name, "Yoshio Shiozaki", is rather quite common amongst Japanese, so, quite possibly there may be another person by the same name with whom the firm had the contract with, and after this man was evacuated the firm lodged their claim with you on his behalf. I have felt it more so due to the fact that your letter was addressed to Lemon Creek while I was at Princeton until a few days ago prior to my transfer to the above address.

Please look into the matter further and correct the error.


