





His wife, Shizue, resides in Japan.



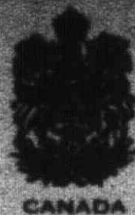
